HFE Valdosta, LLC d/b/a Wild Adventures (“Wild Adventures”) is pleased to offer payroll deduction through your employer listed below (“Employer”) to accommodate purchases for Wild Adventures 2023 season passes. The undersigned customer (“Customer”) hereby authorizes Employer to make payroll deductions in the Total Payment Amount listed above to pay for the applicable 2023 Wild Adventures season passes identified above (“Season Passes”). The payroll deductions will be in the amount and number listed below and the deduction period will start with the next regular paycheck date from the date that Wild Adventures receives this signed agreement. Upon signing this agreement, Customer will be provided with a confirmation number to present to Wild Adventures in person to receive the Season Passes.

Customer acknowledges and agrees that if Wild Adventures does not receive any applicable payroll deduction payment when due or if the Total Payment Amount is not paid in full by June 15, 2023, that Wild Adventures may immediately suspend or revoke the Season Passes and Customer may be refused admission until the remaining balance is paid. Customer acknowledges that Customer may pay off the total amount due for the Season Passes at any time without penalty. The Season Passes provide Customer with revocable privileges which may be changed or cancelled by Wild Adventures at any time without notice. The Season Passes may be revoked for any reason, including, but not limited to if Customer or anyone for whom Customer purchased a Season Pass under this agreement engages in activity which Wild Adventures, in its sole discretion, deems improper.

ALL PURCHASES ARE FINAL AND THE PURCHASE MAY NOT BE CANCELLED OR RESCINDED; NO REFUNDS WILL BE ISSUED. IF YOU HAVE NOT USED A SEASON PASS, YOU MAY CANCEL FUTURE PAYROLL DEDUCTIONS NOT YET MADE BUT YOU MAY NOT RECEIVE A REFUND ON ANY PAYROLL DEDUCTIONS PREVIOUSLY MADE.
